Example:

John claims exemptions for himself, his spouse, and their three children for withholding tax purposes. He is paid on a semi-monthly basis, and his gross wages for this pay period were \$2,476.

$$1. \quad (G)P - [\$8,500 + (\$930)E1] = T$$

$$(\$2,476)24 - [\$8,500 + (\$930)5] = T$$

$$\$59,424 - \$13,150 = \$46,274$$

$$2. \quad T \text{ is over } \$17,000$$

$$\$720 + 5.75\% \text{ of } \$29,274 = W$$

$$\$720 + \$1,683 = \$2,403$$

$$3. \quad W \div P = W/H$$

$$\$2,403 \div 24 = \$100$$

The tax to be withheld for the current period is \$100.
